

25 Tweets for FAFSA Completion

- 1. The new FAFSA for the 2014-15 school year is now available! Let the funds begin: www.fafsa.gov.
- 2. One thing you don't need for the FAFSA? Money! Remember, the FAFSA is FREE when you use the official .gov site: www.fafsa.gov.
- 3. The first "F" in FAFSA stands for FREE. You never have to pay to complete the application. It's available for free at www.fafsa.gov.
- 4. \$150B in aid available & everything starts with filling out the @FAFSA. Don't leave \$ on the table. www.fafsa.gov
- 5. Some financial aid is 1st come, 1st served, so apply ASAP. Check your school & state @FAFSA deadlines here: http://www.fafsa.ed.gov/deadlines.htm
- 6. If you're a #college #student or applying for school, make sure you complete the @FAFSA as soon as possible: www.fafsa.gov
- 7. In order to complete the <u>#FAFSA</u>, you'll need a <u>@FAFSA</u> PIN. Don't wait! Apply now: <u>http://pin.ed.gov/PINWebApp/pinindex.jsp</u>
- 8. There's NO income cut-off for federal student aid. Everyone should fill out the FAFSA: www.fafsa.gov.
- 9. Learn how the @FAFSA gives you access to grants, loans & work-study jobs that can help you pay for college: http://www.youtube.com/watch?v=c-23SMf5DyQ&feature=plcp
- 10. Do you have to provide your parents' information on the FAFSA? Use this <u>#infographic</u> to find out: http://studentaid.ed.gov/sites/default/files/dependency-status.png
- 11. Haven't filed taxes yet? You can still complete @FAFSA! Use 2012 taxes to estimate, then update FAFSA once you file: http://studentaid.ed.gov/fafsa/filling-out#financial-info
- 12. Did you know? You can complete FAFSA using income estimates and then update once you have filed your taxes: http://studentaid.ed.gov/fafsa/filling-out
- 13. Remember, filling out the @FAFSA is not a one-time thing. You must complete the FAFSA every year you attend school: www.fafsa.gov

- 18. March is a huge month for @FAFSA deadlines! Make sure you check both your state AND school deadlines: http://www.fafsa.ed.gov/deadlines.htm

- 20. PARENTS: Confused about the #financialaid process? Learn how you can help your student prepare: http://studentaid.ed.gov/resources/parents
- 21. Even if you missed your state and/or school's @FAFSA deadline, still complete the #FAFSA. You may qualify for federal financial aid: www.fafsa.gov

- 24. If your school asks for additional info to verify your @FAFSA data, provide what is requested ASAP so your #financialaid isn't delayed.
