The California College Guidance Initiative (CCGI)

The equity-focused nonprofit that manages **CaliforniaColleges.edu**, the state of California's official college and career planning and transition platform.

CCGI seeks to:

- Ensure that all California high school seniors graduate with a plan for life after high school.
- 2) Simplify and streamline college and financial application processes.
- Provide K-12 educators and postsecondary systems with the data they need to make accurate and timely decisions that impact student success.

Under the Cradle-to-Career System (AB 132)

CCGI is charged with:

Providing college and career planning lessons.

Auditing "A-G" data against CMP and supporting school districts with clean-up.

Offering technical assistance to school districts on both data clean-up and implementation.

Pre-populating applications for admissions and financial aid.

Transmitting Cal-Grant GPA.

Developing additional tools as specified.

Fully subsidized for districts:

All of the student-focused and parent-focused college and career planning and transition tools on CaliforniaColleges.edu, along with associated reporting for educators.

CSU and UC Eligibility tools to help increase "A-G" completion rates.

Technical assistance for "A-G" course clean-up from CCGI.

Integrations that allow the launch and monitoring of CCCApply, Cal State Apply, Apply UC, and financial aid applications from within one account.

Unlimited virtual training and individual user support for educators.

CCGI's Approach

Manage CaliforniaColleges.edu and its associated infrastructure, tools, and 6th-12th grade college and career planning lessons.

Train educators in how to use CaliforniaColleges.edu functionality, support planning for integration of CaliforniaColleges.edu tools in classrooms and counseling interventions, and provide user support.

Facilitate K-12 course-data review and cleanliness process to ensure "A-G" courses are flagged accurately. Provide a secure method for matching student identifiers and transmitting student transcript data across educational systems.

Why is "A-G" Course Clean-Up Important?



There are discrepancies between how school districts tag "A-G" courses in their student information systems and the UCOP Course Management Portal (CMP).



Mismatches in "A-G" coursework can result in students being unfairly denied admission to a CSU or UC.



Accurate data can help to facilitate both admissions and placement and move students more quickly into the financial aid processes.

CMP "A-G" Matching Criteria for Eligibility Tools

Course Data Element	Matching Requirement for Pre-Validation
County-District-School Code (CDS) OR CEEB Code	Same School (in CMP)
Academic Year	Same School Year (in CMP)
Subject Area	Same Subject Area (in CMP)
 Local Courses match on one of the following two criteria: Local Course ID Transcript Abbreviation match based on CSU Abbreviation Substitution list 	Same Course ID or Transcript Abbreviation (in CMP)

What is an "A-G" Mismatch?

Discrepancies between the way "A-G" courses are listed in a district's Student Information System (SIS) and how they are listed in the Course Management Portal (CMP).



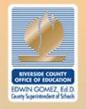

Common Problems and Solutions (In-District)

- **Course Data Integrity.** We support your team in aligning your "A-G" courses with the Course Management Portal.
- One-on-One and Group CMP Meetings. We offer tiered support to ensure that we meet your district where you are and provide the right level of support.

 Assist with staff introduction presentation

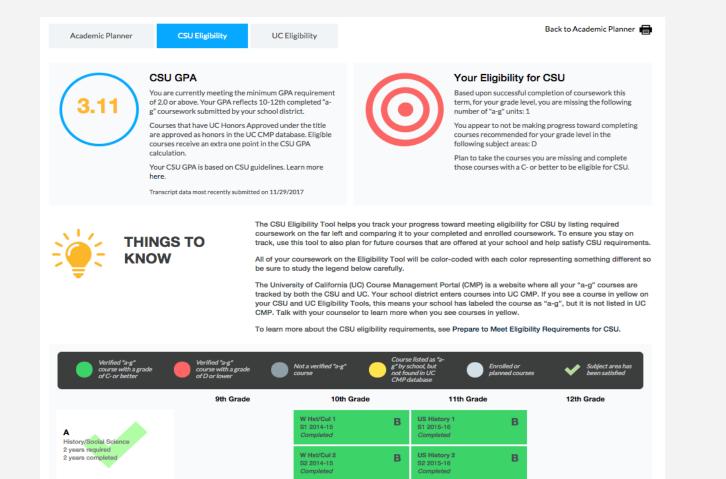
- ✓ Create a site CA Colleges leadership team (i.e. AVID, Spec. Educ., CTE Pathways, or Specialty Programs) and develop training modules

CSU and UC Eligibility Tools

In partner districts, the CSU & UC Eligibility Tools allow students to quickly track their progress toward meeting "A-G" requirements.

Summary

Report Logic:

- Units are measured against University of California recommendations for grade level unit progress.
- · Subject area calculations factor in the number of courses to be completed and the number of years a student has left in high school.
- GPA of 3.0 or better is indicated because it is both the baseline for eligibility for admission to the University of California, and the cutoff for "test-free" admission to the CSU.

The calculation of CSU eligibility is based on the information from the school district's most recent and accurate transcript file submission. If you have any questions please contact your CCGI District Lead.
