**High School Graduation Requirements** 

BP 6146.1

Instruction

The Board of Education desires to prepare all students to obtain a high school diploma to enable them to take advantage of opportunities for postsecondary education and/or employment.

Comprehensive and Virtual High School

### Course Requirements

To obtain a high school diploma, students shall complete at least the following courses in grades 9-12, with each course being one year unless otherwise specified; successful completion of a minimum of 220 semester credits in ninth, tenth, eleventh, and twelfth grades:

1. Four courses in English (Education Code 51225.3)

(cf. 6142.91 - Reading/Language Arts Instruction)

2. Three courses in mathematics (Education Code 51225.3)

At least one mathematics course, or a combination of the two mathematics courses required for completion in grades 9-12, shall meet or exceed state academic content standards for Algebra I. (Education Code 51224.5)

Completion, prior to grade 9, of algebra coursework that meets or exceeds state academic content standards shall satisfy the algebra coursework requirement, but shall not exempt a student from the requirement to complete two mathematics courses in grades 9-12. (Education Code 51224.5)

Students may be awarded up to one mathematics course credit for successful completion of an approved computer science course that is classified as a "category c" course based on the "a-g" course requirements for college admission. (Education Code 51225.3, 51225.35)

3. Three courses in science, including biological and physical sciences (Education Code 51225.3)

5. One course in visual or performing arts, foreign language, including American Sign Language, or career technical education (CTE) (Education Code 51225.3)

To be counted towards meeting graduation requirements, a CTE course shall be aligned to the CTE model curriculum standards and framework adopted by the State Board of Education.

**Continuation High School** 

Course Requirements

To obtain a high school diploma, students shall complete at least the following courses in grades 9-12, with each course being one year unless otherwise specified, Successful completion of a minimum of 200 semester credits in ninth, tenth, eleventh, and twelfth grades:

1. Three courses in English (Education Code 51225.3)

(cf. 6142.91 - Reading/Language Arts Instruction

2. Two courses in mathematics (Education Code 51225.3)

At least one mathematics course, or a combination of the two mathematics courses required for completion in grades 9-12, shall meet or exceed state academic content standards for Algebra I. (Education Code 51224.5)

Completion, prior to grade 9, of algebra coursework that meets or exceeds state academic content standards shall satisfy the algebra coursework requirement, but shall not exempt a student from the requirement to complete two mathematics courses in grades 9-12. (Education Code 51224.5)

Students may be awarded up to one mathematics course credit for successful completion of an approved computer science course that is classified as a "category c" course based on the "a-g" course requirements for college admission. (Education Code 51225.3, 51225.35)

3. Two courses in science, including biological and physical sciences (Education Code 51225.3)

- 6. Two courses in physical education, unless the student has been otherwise exempted pursuant to other sections of the Education Code (Education Code 51225.3)

- 7. 20 hours of community service is required for graduation from the continuation high school.
- (cf. 6142.4 Service Learning/Community Service Classes)
- 8. Completion of Free Application for Federal Student Aid (FAFSA) or California Dream Act application is required for graduation from the continuation high school.

Because the prescribed course of study may not accommodate the needs of some students, the Board shall provide alternative means for the completion of prescribed courses in accordance with law.

## **Retroactive Diplomas**

Until July 31, 2018, any student who completed grade 12 in the 2003-04 school year or a subsequent school year and has met all applicable graduation requirements other than the passage of the high school exit examination shall be granted a high school diploma. (Education Code 60851.6)

## **Administrative Regulation**

**High School Graduation Requirements** 

AR 6146.1 **Instruction** 

Requirements for graduation and specified alternative means for completing the prescribed course of study shall be made available to students, parents/guardians and the public. (Education Code 51225.3)

(cf. 6146.11 - Alternative Credits Toward Graduation) (cf. 6146.2 - Certificate of Proficiency/High School Equivalency)

Students shall not be required to have resided within the district for any minimum length of time as a condition of high school graduation. (Education Code 51411)

Students shall be required to complete a Free Application for Federal Student Aid (FAFSA) or California Dream Act application as part of their high school graduation requirements. The student's high school will identify which students have fulfilled this requirement as indicated by the California Student Aid Commission Report that is generated weekly by the California Student Aid Commission for California high schools.

There may be a number of different reasons why some parents or students may not want to fill out either the Free Application for Federal Student Aid (FAFSA) or the California Dream Act application therefore, these parents/students will have the option to fill out an "Opt Out Form" that would release them from fulfilling this graduation requirement. This form will be available at all of the high schools within Val Verde Unified School District.

Foreign exchange students may receive honorary diplomas pursuant to Education Code 51225.5.

Foreign exchange students will be exempt from completing the Free Application for Federal Student Aid (FAFSA) or California Dream Act application requirement.

Students who complete all requirements for a high school diploma and demonstrate mastery of the curriculum in at least six subject matter areas may qualify for an honors diploma. (Education Code 51450, 51451)

The Golden State Seal Merit Diploma shall be issued to eligible students who demonstrate mastery of mathematics, English language arts, science, United States history and two subject matter areas selected by the student. (Education Code 51450, 51451)

Standards of Proficiency for the Classes of 2001-2003

Student progress toward proficiency in basic skills shall be assessed in English once during grades 7-9 and twice during grades 10-11. A separate assessment shall be made of the student's proficiency in each skill area, and a separate score given in each skill area.

The Superintendent or designee shall provide remedial instruction for any student who does not show adequate progress toward mastery of basic skills. This instruction may be provided in summer school and shall offer the student numerous opportunities to achieve mastery.

Notices shall inform a student's parent/guardian that the student shall not receive a high school diploma unless the prescribed standards are met.

## **Administrative Regulation**

**Promotion/Acceleration/Retention** 

AR 5123

**Students** 

The Board of Education of the Val Verde Unified School District expects students to progress through each grade level within one school year. To accomplish this, instruction should accommodate the varying interests and growth patterns of individual students and include strategies for addressing academic deficiencies when needed.

Students shall progress through the grade levels by demonstrating growth in learning and meeting grade-level standards of expected student achievement.

#### **ACCELERATION**

The Superintendent may recommend a student for acceleration based upon:

- 1. Academic achievement
- a. Grades/GPA
- b. CAAASP results
- 2. Consideration of social and emotional growth

#### PROMOTION/RETENTION

Criteria for promotion, identification of at-risk, and retention are based on teacher grades, proficiency level of standards, district criterion reference tests, and teacher recommendation.

Students in grades 1, 2 and 3 shall be identified primarily on the basis of their level of proficiency in reading. Students in grades 4, 5 and 8 shall be identified in their level of proficiency in language arts, reading and math. Students shall be identified on the basis of grades and district assessments established by the Board. Promotion/Retention for Special Education students will also be addressed through the IEP process.

Designated Retained: (Identified Benchmark 5 and/or 6 - Placed into intervention)

Receives a combination of 6 or more F semester grades in core academic areas of Math, Language Arts, Science, and Social Science.

Standards Proficiency Levels: Determined by standards based multiple assessments in grades 1-5 and 8.

Outstanding Achievement - (A) Superior grade level knowledge and skills.

Above Average Achievement - (B) Grade level knowledge and skills.

Average Achievement - (C) Minimal grade level knowledge and skills.

Below Average Achievement - (D) Lacking grade level knowledge and skills.

Little or No Achievement - (F) Extremely lacking grade level knowledge and skills.

\*\* Retention in the 9th grade is limited to 1 year.

Retention/Intervention Strategies (Response to Intervention)

The identification of at-risk students shall be determined at each grading period. Site teams consisting of the principal and lead teachers designated by the principal will identify students.

Each site will notify in writing to the parents/guardians of each student identified to participate in an intervention program.

## Intervention programs:

- 1. After School Programs
- a. Reading Improvement
- b. Math Improvement
- c. Language Skills Improvement
- 2. Summer School Programs

Students determined to be retained shall participate in a summer school program targeted to improve levels of proficiency. \* An evaluation of each student will occur at the end of the summer school. Students who meet promotion criteria will be promoted to the next grade level. Students not meeting promotion criteria will be retained in their current grade level.

Promotion or retention of Special Education students is determined by current assessment of the Individualized Education Plan (IEP) by the IEP team and the approval of the Special Education Director.

\*When funding is available.

### **Appeal Process**

The teacher's decision to promote or retain a student may be appealed consistent with Board Policy, Administrative Regulation, and law. The burden shall be on the appealing party to show why the decision should be overruled.

To appeal a teacher's decision, the appealing party shall submit a written request to the Superintendent or designee specifying the reasons why the teacher's decision should be overruled. The appeal must be initiated within 10 school days of the determination of retention or promotion. The teacher shall be provided an opportunity to state in writing the criteria on which the decision was based.

Within 30 days of receiving the request, the Superintendent or designee shall determine whether or not to overrule the teacher's decision. Prior to making this determination the Superintendent or designee may meet with the appealing party and the teacher. If the Superintendent or designee determines that the appealing party has proven that the decision should be overruled, then the decision shall be overruled.

The Superintendent's or designee's determination may be appealed by submitting a written appeal to the Board within 15 days. Within 30 days of receipt of a written appeal, the Board

shall meet in closed session to decide the appeal. The Board's decision is made on the basis of written documentation prepared as part of the appeal process. The decision of the Board shall be final.
